AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NOS. 00-16678-1 AND NO. 00-16678-2, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$14,996,462 FROM THE UNAPPROPRIATED FUND BALANCE OF THE SEWERAGE UTILITY REVENUE FUND (41506); AMENDING SECTION 2, SUBSECTION VI, ITEM 3, ENTITLED "SEWERAGE. UTILITY REVENUE FUND (41506) " TO INCREASE NON-PERSONAL EXPENSE AND TOTAL BY SAID \$14,996,462; AND DIRECTING THE AUDITOR AND COMPTROLLER TO SET ASIDE, TRANSFER AND ALLOCATE THE \$14,996,462 APPROPRIATED ABOVE AS TO THE SEWERAGE UTILITY REVENUE FOLLOWS: FUND, UNALLOCATED RESERVE THE SUM OF \$2,906,462 AND TO THE WASTEWATER CONSTRUCTION PROGRAM (70492), CIP NO. 46-118.0, SEWER PUMP STATION 64 AND FORCE MAIN, THE SUM OF. \$12,090,000.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. 00-16678-1 and No. 00-16678-2, as amended and adopted therein, by transferring the sum of \$14,996,462 from the Unappropriated Fund Balance of the Sewerage Ptility Revenue Fund (41506).

Section 2. That Section 2, Subsection VI, Item 3, entitled "Sewerage Utility Revenue Fund (41506)" is hereby amended to increase non-personal expense and total by said \$14,996,462.

Section 3. That the Auditor and Comptroller is hereby directed to set aside, transfer and allocate the \$14,996,46? appropriated above as follows: to the Sewerage Utility Revenue Fund, Unallocated Reserve the sum of \$2,906,46? and to the Wastewater Construction Program (70492), CIP No. 46-118.0, Sewer Pump Station 64 and Force Main, the sum of \$12,090,000.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

This ordinance amends the annual appropriation ordinance by appropriating additional funds (heretofore unappropriated) in the amount of \$9,253,170 and increasing the appropriation to the General Fund by \$5,962,820 and the Capital Outlay Fund by \$2,270,350. It further transfers sales tax revenues from the General Fund 100 to the Wet Lands Acquisition Fund (10545) [\$1,400,000]; to the Environmental Growth Fund (10505) [\$906,329]; and to the Capital Outlay Fund (3024b) [\$399,650].

The remainder of the increased appropriation to the General Fund 100 [s. allocated purguant to Council direction and further there is established new CIP projects and increased funding for existing CIP projects.
