AN ORDINANCE PREZONING A PORTION OF PARCEL 2
OF PARCEL MAP 8630, AND A PORTION OF SECTION
32, TOWNSHIP 14 SOUTH, RANGE 2 WEST, SBBM,
LOCATED ON THE EAST SIDE OF SCRIPPS RANCH
BOULEVARD, BETWEEN SCRIPPS RANCH BOULEVARD AND
SCRIPPS LAKE DRIVE, IN THE SCRIPPS-MIRAMAR
RANCH COMMUNITY PLAN AREA, IN THE COUNTY OF
SAN DIEGO, CALIFORNIA, INTO A-1-10 ZONE AS
DEFINED BY SECTION 101.0404, OF THE SAN DIEGO
MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Parcel 2 of Parcel Map 8630, and a portion of Section 32, Township 14 South, Range 2 West, SBBM, located on the east side of Scripps Ranch Boulevard, between Scripps Ranch Boulevard and Scripps Lake Drive, in the Scripps-Miramar Ranch Community Plan area, in the County of San Diego, California, within the boundaries of the district designated "A-1-10" on that certain Zone Map Drawing No. B-3760, filed in the office of the City Clerk under Document

No. 769440, be, upon annexation to the City of San Diego, incorporated into A-1-10 Zone as defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
