AN ORDINANCE INCORPORATING VARIOUS PROPERTIES IN THE SOUTH BAY AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA-RR ZONE, AS DEFINED BY SECTION 101.0427.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING VARIOUS ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:
