ORDINANCE NUMBER O- 16774 (NEW SERIES)

ADOPTED ON DEC 08 1986

AN ORDINANCE INCORPORATING LOT 4, BLOCK 3, LOMA GRANDE, MAP NO. 692, LOCATED ON THE EAST SIDE OF FOURTH AVENUE, BETWEEN BROOKE AND WALNUT AVENUES, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988 (NEW SERIES), ADOPTED NOVEMBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 4, Block 3, Loma Grande, Map No. 692, located on the east side of Fourth Avenue, in the Uptown Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3795, filed in the office of the City Clerk as Document No. 769450 be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.


