AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16678-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE FIRE DEPARTMENT (120), IN GENERAL FUND 100, BY ADDING ONE (1.00) FIRE ASHIFT COMMANDER POSITION AND DELETING ONE (1.00) FIRE BATTALION CHIEF POSITION IN THE FIRE OPERATIONS PROGRAM (12040); EXEMPTING SAID FIRE SHIFT COMMANDER POSITION FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, it has been proposed that a Fire Shift Commander position be authorized in the Fire Operations Program of the Fire Department for purposes of implementing an administrative reorganization; and

WHEREAS, the position is proposed for the Unclassified

Service and will replace one (1.00) Fire Battalion Chief position

in the Classified Service; and

WHEREAS, this restructuring of duties will create a fourth Shift Commander; and

WHEREAS, due to the emergency response requirements of this position, whenever one of the current three Shift commanders is on leave, the position is filled through out-of-class assignments; and

WHEREAS, a lack of administrative continuity has developed at this unclassified position because of constantly rotating persons; and

WHEREAS, this position will fill the relief needs and be available to the Fire Chief for other non-emergency managerial and special project eassignments; and

WHEREAS, these duties and responsibilities are comparable to those of the other three Shift Commander positions which have been placed in the Unclassified Service; and

WHEREAS, it has been further requested that the newly authorized Fire Shift Commander position be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on November 6, 1986 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said addition and exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16678-1, as amended and adopted therein, by adding one (1.00) Fire Shift Commander position and deleting one (1.00) Battalion Fire Chief position from the personnel authorization of the Fire Department (120), Fire Operations Program (12040).

Section 2. That pursuant to section, 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on November 6, 1986, the Fire Shift Commander position authorized herein is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, identified as Exhibit C to Ordinance No. O-16649 (New Series), dated May 27,1 986, be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

The ordinance also exempts the Fire Shift Commander position from the Classified Service and places it in the Unclassified Service and establishes a rate of pay for said position.
