


**RESOLUTION No.** R-264774 (R-86-1011)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of NATURESCAPE LANDSCAPE INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF KEARNY MESA PARK as may be required for a period of one (1) year beginning January 1, 1986 through December 31, 1986, at a cost of \$3,616.00 per month, for a total cost of \$43,392.00; terms net 30 days, with an option to renew contract for four (4) additional one (1) year periods with a price escalation not to exceed 10% for each option year.
