


RESOLUTION No. R-264785 (R-86-1014)

Adopted on JAN 6 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE RECONSTRUCTION OF SIDEWALK IN NORMAL HEIGHTS FIRE AREA, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on JAN 6 1986 and bearing official Document No. U.D. 118792 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE RECONSTRUCTION OF SIDEWALK IN NORMAL HEIGHTS FIRE AREA.
4. That the City Manager and the City Auditor and Comptroller are directed and they are hereby authorized to add CIP No. 52-346 RECONSTRUCTION OF SIDEWALK IN NORMAL HEIGHTS FIRE AREA as a CIP project to the Fiscal Year 1986 Capital Improvements Program.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$52,000 from Fund 100, Department 534, Organization 100, Object Account 4222, Job Order 003102 to CIP No. 52-346 RECONSTRUCTION OF SIDEWALK IN NORMAL HEIGHTS FIRE AREA.
6. That the expenditure, not to exceed \$52,000 from CIP No. 52-346 RECONSTRUCTION OF SIDEWALK IN NORMAL HEIGHTS FIRE AREA for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
