BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, bearing date of August 15, 1985; LUSK-SMITH/MIRA MESA NORTH, a limited partnership, bearing date of November 4, 1985; and H. G. FENTON MATERIAL COMPANY, a California corporation, bearing date of September 3, 1985, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 264791-1, RR- 264791-2 and RR- 264791-3, granting to said City easements for public street purposes in a portion of the Northwest Quarter of the Northwest Quarter (Lot 4) of Section 2, Township 15 South, Range 3 West, San Bernardino Meridian, and in portions of Parcels 4 and 5 of Parcel Map No. 13071, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named FLANDERS DRIVE, MIRA MESA BOULEVARD, CAMINO SANTA FE and SCHILLING AVENUE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
