

RESOLUTION NUMBER R- 264801

ADOPTED ON JAN 6 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of DANIEL T. MCSWEENEY, Trustee of the Daniel T. McSweeney Declaration of Trust dated April 8, 1985, executed in favor of The City of San Diego, bearing date of August 22, 1985, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 264801-1, granting to said City an easement for public street purposes, being the northerly 5.00 feet in even width of Lot 9 of La Jolla Scenic West, Map 8482, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named HILLSIDE DRIVE.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that slope easement deed of DANIEL T. MCSWEENEY, Trustee of the Daniel T. McSweeney Declaration of Trust dated April 8, 1985, executed in favor of the City of San Diego, bearing date of August 22, 1985, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 264801-2, granting to said City a 5.69-foot by 92.66-foot portion of the open space easement as shown on Drawing No. 16513-B.


BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of

The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-264801-2³ quitclaiming to DANIEL T. MCSWEENEY, Trustee of the Daniel T. McSweeney Declaration of Trust dated April 8, 1985, that portion of open space easement which is to be dedicated to street purposes pursuant to this resolution, in consideration of the grant of street easement and the grant of slope easement as described in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
