BE IT RESOLVED, by the Council of The City of San Diego, that the City of San Diego hereby indemnifies and holds the San Diego Stadium Authority harmless for the first one million dollars (\$1,000,000) of public liability and property damage risk.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to continue to provide public liability and property damage insurance coverage over one million dollars (\$1,000,000) for the San Diego Stadium Authority by addition of the Authority to the City of San Diego's excess public liability insurance policy.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to provide for all claims administration services through the City's self administered claims division and to provide for the defense of any litigated claims by the City Attorney.
