

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$144,500 from the Mission Bay Revenue Fund No. 10504, C.I.P. 22-024.1, South Shores Development Phase I, is hereby authorized, solely and exclusively to supplement funds previously authorized by Resolution Nos. R-254612, and R-261319 for the above purpose.


