
RESOLUTION NUMBER R- 264820

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Kercheval and Associates, Inc., for design consultant services in connection with providing bicycle lanes on Black Mountain Road from Kearny Villa Road to Mira Mesa Boulevard and on Genesee Avenue from Clairemont Mesa Boulevard to Linda Vista Road, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 264820 .

BE IT FURTHER RESOLVED, that the expenditure of amounts not to exceed \$22,300 from Fund No. 39005 C.I.P. 58-053, Black Mountain Road Bikeway, and \$17,200 from C.I.P. 58-052 Genesee Avenue Bikeway III, are hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
