RESOLUTION NUMBER R- 264822

ADOPTED ON JAN 6 1986

WHEREAS, bicycle count surveys provide a useful planning and evaluation tool for City transportation planners and engineers including information as to the level of bicycle usage at different locations within the City and, whether bicycle usage is increasing, decreasing or remaining steady at specific locations over a period of time, indications of the need for new or upgraded bicycle routes and facilities, public acceptance of existing bicycle routes and support facilities (e.g., bicycle parking, racks and lockers); and

WHEREAS, CALTRANS annually conducted these surveys throughout the San Diego region from 1981 to 1984 as an element of its work program; and

WHEREAS, recent modifications to CALTRANS' bicycle program resulted in deletion of these surveys and in order to continue collecting this data, City staff has arranged for SANDAG to provide technical assistance to conduct surveys at "Master Stations" within the City; and

WHEREAS, The City of San Diego is eligible to receive local Transportation Development Act (TDA) nonmotorized funds, administered by SANDAG, for this purpose; and

WHEREAS, upon receipt of the funds, the City will reimburse SANDAG for the cost of conducting bicycle count surveys within the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is fully authorized and empowered to submit a claim to SANDAG for \$5,000 of local Transportation Development Act (TDA), Article 3 nonmotorized funds and, upon approval of said claim, accept said \$5,000 on behalf of The City of San Diego.

2. That the City Manager be and he is hereby further authorized to approve, and the City Auditor and Comptroller is authorized to expend, the sum of \$5,000 in local TDA nonmotorized funds when received, for the purpose of enabling SANDAG to conduct bicycle surveys at "Master Stations" within the City.
