A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE DESIGN AND CONSTRUCTION FOR THE PUBLIC RESTROOMS TO BE BUILT ADJACENT TO THE CIVIC THEATRE ON THE THIRD AVENUE FRONTAGE.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has undertaken certain redevelopment projects in the Centre City area; and

WHEREAS, the Council of The City of San Diego directed the Centre City Development Corporation and the City Manager to proceed with the design and preparation of contract drawings and specifications for public restrooms to be built in the Community Concourse complex on the west side of Third Avenue northerly of C Street and adjacent to the Civic Theater; and

WHEREAS, the basic concept drawings have been reviewed and recommended for approval by the Centre City Development Corporation, the Committee on Public Facilities and Recreation and the Planning Commission of The City of San Diego; and

WHEREAS, the Council adopted on May 20, 1985, by Resolution No. R-263234 that capital outlay funds in the amount of \$200,000.00 identified in CIP No. 39-073 were disbursed to the Agency for the design and construction of restrooms; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The Council has reviewed the plans for the public restrooms.
 - 2. The Council hereby approves of said plans.
- 3. The Centre City Development Corporation is hereby authorized, on behalf of the Council, to advertise and receive bids for the construction of restrooms to be built on the west side of Third Avenue adjacent to the Civic Theatre.
- 4. That the Executive Director of the Agency, or his designee, is hereby authorized to award the contract to the lowest responsible qualified bidder provided said bids are within the established budget for construction of the restrooms.
- 5. That the expenditure shall not exceed \$156,000.00 from the City Capital Improvement Budget for the construction.
- 6. That the Centre City Development Corporation is hereby authorized, on behalf of the Council, to administer said contract.
