RESOLUTION NUMBER R- 264840 ADOPTED ON JAN 1 3 1986

WHEREAS, January 25, 1986 marks the 13th anniversary of the Paris Peace Treaty, designed to honorably conclude the war in Indochina; and

WHEREAS, that Treaty provided for the speedy and safe return of all American POWs and MIAs; and

WHEREAS, thirteen (13) years later the government of North Vietnam and its satellites in Cambodia and Laos have ignored the Treaty by: (1) failing to assist in determining the fate of over 1,000 American MIAs and (2) refusing to cooperate with the United States Government and surviving relatives and friends of these MIAs; and

WHEREAS, reliable eyewitness accounts confirm the continued existence of captured Americans in Indochina; and

WHEREAS, public pressure and awareness are our principal weapons to secure the release of remaining MIAs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Saturday, January 25, 1986 be proclaimed "Remember the MIAs" day in San Diego.
- 2. That Ms. Barbara Lowerison, and "Operation Skyhook" be and they are hereby commended for keeping this issue of conscience constantly prominent in public awareness.

- 3. That the City Manager is authorized to provide staging, chairs, tables, loudspeakers and other support to the "Remember the MIAs" rally, adjacent to the War Memorial Building in Balboa Park, on January 25, 1986.
- 4. That the Intergovernmental Relations Department is directed to draft appropriate language for a City resolution to be forwarded to the President of the United States and the local congressional delegation regarding increased efforts to secure the release of remaining MIAs.
