

RESOLUTION NUMBER R- 264841 ADOPTED ON JAN 1 3 1986

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to bidders calling for bids for the purchase of an optical mark reader as per specifications on file in the office of the Purchasing Agent.
- That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder.
- That the City Auditor and Comptroller is hereby authorized to transfer \$80,331 from the Unallocated Reserve to the Personnel Department to purchase this equipment, and to further encumber \$4,000 for contingency purposes to cover unexpended freight, installation, or related expenses from the Personnel Department's Non-personnel Expense Fund.



4. That the expenditure not to exceed \$80,331 is hereby authorized solely and exclusively for the purchase of said equipment and related costs, and further authorizing a contingency expenditure not to exceed \$4,000 from the contingency funds hereby encumbered, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
