RESOLUTION NUMBER R- 264843

ADOPTED ON JAN 13 1986

WHEREAS, Dr. Martin Luther King, Jr. was a most revered spiritual voice in the Black communities across the nation; and

WHEREAS, Dr. King was also one of the leading forces in this country who devoted his life to civil rights for Black persons; and

WHEREAS, Dr. King sacrificed his life in the pursuit of that cause; and

WHEREAS, a national holiday has been declared in his honor, occurring on January 20, 1986; and

WHEREAS, much interest has been generated in naming (or renaming) a major San Diego street after and in honor of Dr. King; and

WHEREAS, the Rules Committee, on January 6, 1986, heard a presentation in that regard and approved unanimously the concept of so honoring Dr. King; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of all the people of San Diego, does hereby express its approval of the concept of naming a major San Diego street, state freeway or prime arterial after and in honor of Dr. Martin Luther King, Jr.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to report back to the Council with his

recommendations in this matter after consultation with appropriate agencies and bodies.
