WHEREAS, Joan Kroc is one of San Diego's most enthusiastic supporters of social and philanthropic endeavors; and

WHEREAS, Joan Kroc has given her time, her resources, her aid, concern and compassion in an ongoing effort to attend to human needs; and

WHEREAS, this genuine concern has been demonstrated and institutionalized by her in the establishment of the Joan B. Kroc Foundation, initiated in 1984, to sustain programs and activities to help people accept and overcome conditions that may undermine individual worth and family love; and

WHEREAS, the Joan B. Kroc Foundation has made generous commitments to medical research, the prevention of child abuse, services for homeless women, distribution of food to the needy, aid for senior citizens, and adoption training; and

WHEREAS, the Joan B. Kroc Foundation was most recently the catalyst for a joint cooperative effort, bringing together the City and County of San Diego to create a 24-bed hospice facility on Vauclain Point; and


