


RESOLUTION No. R-264854 (R-86-1192)

Adopted on JAN 21 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for NESTOR CREEK FLOOD CONTROL PROJECT 1A, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on January 21, 1986 and bearing official Document No. W.O. 118611 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for NESTOR CREEK FLOOD CONTROL PROJECT 1A.
4. That the City Auditor and Comptroller is hereby authorized to consolidate CIP No. 12-036.2 NESTOR CREEK FLOOD CONTROL PROJECT 1B into CIP No. 12-036.1 NESTOR CREEK FLOOD CONTROL PROJECT 1A.
5. That the expenditure of \$10,000 from Federal Revenue Sharing Fund 18013 CIP No. 12-036.1 NESTOR CREEK FLOOD CONTROL PROJECT 1A, to supplement funds previously authorized by Resolution R-264219, adopted on October 14, 1985, is hereby authorized for litigation, appraisal and related fees necessary to acquire the remaining property rights required for the project.
6. That the expenditure, not to exceed \$671,000 from Federal Revenue Sharing Fund 18013 CIP No. 12-036.1 NESTOR CREEK FLOOD CONTROL PROJECT 1A is hereby authorized solely and exclusively for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
