1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No. RR-264865, be, and the same is hereby authorized to be sold by negotiation for the amount of ONE HUNDRED FORTY-FIVE THOUSAND DOLLARS (\$145,000) to THE UNITED STATES OF AMERICA.

That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. RR-264865 granting to THE UNITED STATES OF AMERICA all that portion of Lot 2, Riverview Farms, as more particularly described in said grant deed.
- 3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
