
RESOLUTION NUMBER R- 264867

Legal Description of Dedicated Park Lands
Being Renamed as Tecolote Canyon Natural Park

Parcel 1

All that or Mt. Brundage Park dedicated by Ordinance 9610 on April 4, 1967, more particularly described as follows:

Lot 911 of East Clairemont Unit 7, according to Map thereof No. 4006, filed in the County Recorder's Office in San Diego County, November 7, 1958; Excepting therefrom that portion designated "Reserved for Future Street" on said map.

Parcel 2

All that portion of Kelly Street Park dedicated by Ordinance 11048 on May 1, 1973, more particularly described as follows:

All that portion of Pueblo Lots 1179, 1180, 1189 and 1190 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascol in 1870, a copy of which map was filed in the Office of the San Diego County Recorder November 14, 1921, as Miscellaneous Map 36, more particularly described as follows:

Beginning at the Northeasterly corner of Lot 12 of Block 26 of Linda Vista Unit 5, according to the Map thereof No. 3208, filed in the Office of said County Recorder; thence along the Northwesterly boundary of said Linda Vista Unit 5, the following distances and bearings: South 72°56'59" West 272.64 feet; thence North 17°00'15" West 70 feet; thence South 71°12'31" West 219.92 feet; thence South 65°57'32" West 163.71 feet; thence South 26°21'35" East 70 feet; thence South 60°55'08" West 147.48 feet; thence North 36°00' West 700 feet; thence North 86°00' West 400 feet; thence North 20°28'59" East 360 feet; thence North 53°28'59" East 300 feet; thence North 81°07'39" East 178.46 feet; thence South 19°06'01" East 682 feet; thence North 82°19'59" East 316 feet; thence South 67°48'01" East 331.72 feet; thence South 49°32'31" East 204.73 feet, returning to the Point of Beginning.
