
ADOPTED ON JAN 21 1986

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$5,000 from C.I.P. No. 23-527, Chollas Community Park Comfort Station, Federal Revenue Sharing Fund 18013, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
