RESOLUTION NUMBER R- 264888

ADOPTED ON JAN 21 1986

WHEREAS, January 25, 1986 marks the thirteenth anniversary of the Paris Treaty, which ended the war in Indochina; and

WHEREAS, the Treaty provided for the speedy and safe return of all U.S. prisoners of war or soldiers missing in action; and


WHEREAS, there is evidence that U.S. soldiers may still be alive in Indochina; and

WHEREAS, the Council of The City of San Diego has proclaimed January 25, 1986 "Remember the MIAs" day in San Diego, NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, calls upon the President of the United States and the local congressional delegation to make an increased effort to secure the release of any MIAs remaining in captivity.

BE IT FURTHER RESOLVED, that the City Clerk and Director of Intergovernmental Affairs be and they are hereby directed to forward copies of this resolution to the White House and to each member of our local congressional delegation.
