WHEREAS, the Red Cross has provided emergency assistance to five million people affected by floods, hurricanes, tornadoes and mud slides in the United States since September 1985; and


WHEREAS, the Red Cross depends upon the American people to carry on and support its work; NOW, THEREFORE,
