

RESOLUTION NUMBER R- 264907

APPROVING MAP OF CARMEL VALLEY NEIGHBORHOOD 6  
UNIT 3.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Gary Wesch, R.C.E., entitled "CARMEL VALLEY NEIGHBORHOOD 6 UNIT 3 being a subdivision of Parcel 1 of Parcel Map No. 14027, in the City of San Diego, County of San Diego, State of California, according to Map thereof, filed in the office of the County Recorder of San Diego County, November 18, 1985," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Camino Mira Del Mar and a portion of pedestrian and non-motor vehicular right-of-way and said street and portion of a right-of-way are hereby declared to be a public street and portion of a public pedestrian and non-motor vehicular right-of-way and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage, water and sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1 through 3 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over Lot 3, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portion of a pedestrian and non-vehicular right-of-way are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage, water and sewer facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
