WHEREAS, by Resolution No. R-263563, adopted by this Council on July 1, 1985, the City Manager was authorized to execute fourteen (14) agreements with structural engineering firms to provide structural plan-checking services for the Building Inspection Department of The City of San Diego for Fiscal Year 1986; and

WHEREAS, Resolution No. R-263563 also authorized the expenditure of \$100,000.00 from Fund No. 41300 for said services; and

WHEREAS, as of this date, most of the \$100,000.00 budgeted for these purposes have been expended or committed for expenditure; and

WHEREAS, building permit activity is continuing at a high level and it is estimated that an additional \$75,000.00 may be needed for the remainder of Fiscal Year 1986 to avoid excessive delays in the plan-check process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$75,000.00 from the Building Inspection Department's Enterprise Fund No. 41300, to pay for additional contract plan-check services, is hereby authorized.
