
RESOLUTION NUMBER R- 264930

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those water and drainage easement deeds of P AND G COMPANY, a California corporation, dated September 13, 1985; TERRAL INVESTMENT COMPANY, a California corporation, dated October 31, 1985; and NATIONAL ACADEMY OF SCIENCE, a corporation (Roger R. Revelle and J. Bruce Henderson, co-trustees), all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 264930-¹, RR- 264930-² and RR- 264930-³, granting to said City easements for water and drainage purposes in Lot 2, Map 6737, San Diego Center, Unit No. 2; in Parcel 1, Parcel Map 7413; and in portions of the South Half of the Southwest Quarter, Section 1, Township 14 South, Range 4 West, San Beernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
