Leroy Staley	Police	\$5,000.	Mr. Staley is a Sergeant. He suggested that arresting officers administer the GCI breath test. One year's experience has resulted in savings of \$27,100.50. This is the full award.
George R. Morton	Engineering & Development	\$1,000.	Mr. Morton is a Project Officer I in the Design Division. He suggested modifying the Caltrans LAAPS program to reduce the cash deposit requirement and establish an interest yielding trust account. This has resulted in a savings of \$1,633,038. This is the full award.
