Edward M. Wiseman	Utilities	\$90.	Mr. Wiseman is a Wastewater Plant Operator with the Quality Division. He suggested the installation of a door bell at the Alvarado Filtration Plant. Although savings are difficult to identify, this was considered to be a significant operational improvement.
August F. Ghio	Fire	\$90.	Mr. Ghio is a Captain. He suggested that Strike Teams leave mapbooks and prefire plans for reserve crews. Although savings are difficult to identify, this was considered to be a significant safety improvement.
Robert F. Glass	Fire	\$80.	Mr. Glass is an Engineer. He suggested equipping triple combination pumpers with galvanized steel diamond plate hose covers. Although savings are difficult to identify, this is considered to be a significant operational improvement.
