

RESOLUTION No. R-264948 (R-86-1190)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That all bids theretofore received on October 6, 1983, pursuant to publication of notice calling for bids on TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS are hereby rejected.
2. That the amended plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS filed in the office of the City Clerk of the City of San Diego, California, on FEB 3 1986, and bearing official Document No. W.O. 118409, be, and the same are hereby approved.
3. That the Purchasing Agent of the City of San Diego, be and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
4. That the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS, San Diego, California.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$20,000 from PSD Fund 11340 to CIP No. 23-590.4 TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS.
6. That the expenditure of \$20,000 from CIP No. 23-590.4 TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS is hereby authorized to supplement funds previously authorized by Resolution No. R-259160, adopted on September 12, 1983 for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
