COMMUNITY PARK ADDITIONAL IMPROVEMENTS is hereby authorized to supplement funds previously authorized by Resolution No. R-259160, adopted on September 12, 1983 for said project and related costs, and authorizing Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
