
RESOLUTION NUMBER R- 264957

EXHIBIT A
LEGAL DESCRIPTIONS

Street Dedications: Nobel Drive and Shoreline Drive

All that portion of Pueblo Lot 1304 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the Office of the San Diego County Recorder, November 14, 1921, as Miscellaneous Map No. 36, more particularly described in Parcels A and B, as follows:

Parcel A: Nobel Drive

Commencing at the Southwest corner of Pueblo Lot 1304 as shown on Parcel Map No. 11842, said map being filed in the Office of the San Diego County Recorder on December 4, 1981; thence along the Westerly line of said Pueblo Lot 1304 North $00^{\circ}51'51''$ East, 66.64 feet to the Southeast corner of said Parcel Map No. 11842, said point being the TRUE POINT OF BEGINNING and being also a point on the arc of a 2,049.00-foot radius curve, concave Northwesterly, a radial to said point bears South $19^{\circ}42'21''$ East; thence Northeasterly along the arc of said curve through a central angle of $05^{\circ}31'36''$, an arc length of 197.64 feet; thence along a radial from said curve North $25^{\circ}13'57''$ West, 98.00 feet to the beginning of a 1,951.00-foot radius curve, concave Northwesterly, a radial to said point bears South $25^{\circ}13'57''$ East; thence Southwesterly along the arc of said curve through a central angle of $04^{\circ}26'34''$, an arc length of 151.28 feet to a point on said Westerly line of Pueblo Lot 1304, being also a point on the Easterly line of said Parcel Map No. 11842, a radial to said point bears South $20^{\circ}47'23''$ East; thence along said Westerly line of Pueblo Lot 1304 South $00^{\circ}51'51''$ West, 105.05 feet returning to the TRUE POINT OF BEGINNING.

Parcel B: Shoreline Drive

Commencing at the Southwest corner of Pueblo Lot 1304 as shown on Parcel Map No. 11842, said map being filed in the Office of the San Diego County Recorder on December 4, 1981; thence along the Westerly line of said Pueblo Lot 1304 North $00^{\circ}51'51''$ East, 66.64 feet to the Southeast corner of said Parcel Map No. 11842, said point being also a point on the arc of a 2,049.00-foot radius curve, concave Northwesterly, a radial to said point bears South $19^{\circ}42'21''$ East; thence Northeasterly along the arc of said curve through a central angle of $02^{\circ}09'13''$, an arc length of 77.02 feet to the TRUE POINT OF BEGINNING, said point being also the beginning of a 20.00-foot radius curve, concave Southwesterly, a radial to said point bears North $21^{\circ}51'34''$ West; thence Easterly and Southeasterly along the arc of said curve through a central angle of $88^{\circ}36'55''$, an arc length of 30.93 feet; thence tangent to said curve South $23^{\circ}14'39''$ East, 8.14 feet to the beginning of a tangent 20.00-foot radius curve, concave Westerly; thence Southeasterly, Southerly, and Southwesterly along the arc of said curve through a central angle of $44^{\circ}24'55''$, an arc length of 15.50 feet to the beginning of a 50.00-foot radius reverse curve, concave Northeasterly, a radial to said point bears North $68^{\circ}49'44''$ West; thence Southwesterly, Southerly, and

Southeasterly along the arc of said curve through a central angle of $84^{\circ}25'08''$, an arc length of 73.67 feet, a radial to said point bears South $26^{\circ}45'08''$ West; thence South $89^{\circ}05'23''$ East, 43.59 feet to the beginning of a 50.00-foot radius curve, concave Westerly, a radial to said point bears South $24^{\circ}55'54''$ East; thence Northeasterly, Northerly, and Northwesterly along the arc of said curve through a central angle of $132^{\circ}43'40''$, an arc length of 115.83 feet to the beginning of a 20.00-foot radius reverse curve, concave Northeasterly, a radial to said point bears South $22^{\circ}20'26''$ West; thence Northwesterly along the arc of said curve through a central angle of $44^{\circ}24'55''$, an arc length of 15.50 feet; thence tangent to said curve North $23^{\circ}14'39''$ West, 8.14 feet to the beginning of a tangent 20.00-foot radius curve, concave Southeasterly; thence Northwesterly, Northerly, and Northeasterly along the arc of said curve through a central angle of $88^{\circ}36'55''$, an arc length of 30.93 feet to a point on the arc of a 2,049.00-foot radius curve, concave Northwesterly, a radial to said point bears South $24^{\circ}37'44''$ East; thence Southwesterly along the arc of said curve through a central angle of $02^{\circ}46'10''$, an arc length of 99.04 feet returning to the TRUE POINT OF BEGINNING.

(Basis of Bearings: Easterly line of Parcel 1 as shown on Parcel Map No. 11842, i.e., North $00^{\circ}51'51''$ East.)
