(\$16,006), 14341 (\$11,382), 14342 (\$13,655), 14343 (\$9,585), 14350 (\$5,939), 14360 (\$29,446), 14370 (\$3,918), 14380 (\$5,178), 14393 (\$4,891) and \$400,000 of Capital Outlay funds from C.I.P. No. 23-616 Serra Mesa Community Park Development Phase III, FY '87 to C.I.P. No. 29-558 Cabrillo Heights Neighborhood Park - Improvements, F.Y. '87.
