BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$180,000 of park service fees from Park Service District Fund 16730 to C.I.P. No. 29-248 Southwest Neighborhood Park - Acquisition.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$180,000 from C.I.P. No. 29-248 Southwest Neighborhood Park - Acquisition, is hereby authorized, solely and exclusively for the purpose of providing funds for the acquisition of Southwest Neighborhood Park.
