A RESOLUTION OF THE CITY COUNCIL ESTABLISHING COUNCIL POLICY NO. 000-27, ENTITLED "IN-TOWN REIMBURSABLE EXPENSE" AND "OUT-OF-TOWN TRAVEL PROCEDURES.

WHEREAS, the City Council has expressed concern about increased accountability for reimbursing expenses incurred by elected City officials and other specified personnel while conducting official City business in The City of San Diego area; and

WHEREAS, the Council has further expressed concern about establishing policies and procedures in respect to out-of-town travel by all elected City officials, their appointed staff personnel, and members of City boards, commissions and committees while on City business; and

WHEREAS, in connection with the entire area of concern, it has been determined that the use of City credit cards is no longer an appropriate method of financial operation for the City and will terminate January 31, 1986; and

WHEREAS, in connection with the entire concern set forth above, the City Manager [in cooperation with the Auditor and Comptroller] has promulgated Administrative Regulations 90.30 and 95.40, effective January 31, 1986, to govern policies, procedures and accountability for all managerial departments, to which all nonmanagerial departments have agreed to comply; and

WHEREAS, to provide full application of those policies, procedures and accountability methods to elected officials, their staff personnel and members of City boards, commissions and committees, it is necessary and desirable to promulgate a Council Policy which would provide appropriate guidance to those elected and appointed officers and employees; and

WHEREAS, on January 6, 1986, the Rules Committee considered the above matter regarding adoption of a Council Policy containing the necessary procedural guidance as had been developed by the City Manager and Auditor and Comptroller which is embodied in Administrative Regulations 90.30 and 95.40, dated January 31, 1986; and

WHEREAS, after considerable review, discussion and deliberation by the Rules Committee, the matter was recommended for adoption by a 4-0 vote and directed that the item be forwarded to the full Council for action consistent with the action taken and recommended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Council Policy No. 000-27, dated February 3, 1986, a copy of which is on file in the office of the City Clerk as Document No. RR-264968, and the copy prepared by the City Attorney, attached hereto as Attachment A, be and the same is hereby approved and adopted.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to make the necessary addition to the Council

Policy Manual, and publish and distribute the new policy as may be necessary and required.
