APPROVING MAP OF SUMMERS GOVERNOR PARK PLAZA
UNIT NO. 1.

BE IT RESOLVED, that the Council of The City of San Diego hereby finds that certain map surveyed by Ronald C. Parker, L.S., entitled "SUMMERS GOVERNOR PARK PLAZA UNIT NO. 1 being a subdivision of a portion of Lot 16 of Governor Drive Business Park Unit No. 4, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10671, filed in the office of the County Recorder of San Diego County June 30, 1983, and a portion of Parcel 3 of Parcel Map 11432 in the City of San Diego, County of San Diego, State of California, according to Map thereof, filed in the office of the County Recorder of San Diego County, together with portions of Greenwich Drive as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Greenwich Drive, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the

act of the Council, that said Council has approved said subdivision map, and that said public street is accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
