
ADOPTED ON FEB 3 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of October 9, 1985, a copy of which deed is on file in the Office of the City Clerk as Document No. RR-264975, granting to said City an easement for public street purposes in a portion of the Westerly 150.00 feet of Pueblo Lot 1275 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named GREENWICH DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
