RESOLUTION NUMBER R- 264976

ADOPTED ON FEB 3 1986

WHEREAS, POLETTA SUE HUDSON, has requested an exchange of sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of POLETTA SUE HUDSON, executed in favor of The City of San Diego, bearing date of February 14, 1985, conveying to said City a sewer easement in portions of Lots 29 and 30 of Block 85 of Morses Subdivision, Map No. 547, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 264976 is hereby approved.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 264976, quitclaiming to POLETTA SUE HUDSON all of the City's right, title and interest in the sewer easement in Lots 29 and 30 of Block 85 of Morses Subdivision, Map No. 547, as more particularly described in said deed.

3. That the acceptance by the City Manager of those drainage easement deeds of POLETTA SUE HUDSON, dated February 14, 1985, and of LUCIAN SALAZAR and FELICITAS V. SALAZAR, dated February 8, 1985, executed in favor of The City of San Diego, granting to said City storm drain easements in portions of Lots 18, 28, 29, 30 and 31 of Block 85 of Morses Subdivision, Map No. 547, as more particularly described in the deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 264976-3 and RR- 264976-4, is hereby approved.

4. That the City Clerk is hereby authorized and directed to deliver the deeds, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
