RESOLUTION NUMBER R- 264988

ADOPTED ON FEB 3 1986

WHEREAS, Resolution No. R-264734 was adopted on December 16, 1985 for the purpose of amending the original resolutions of appointment [R-264613 and R-264597] as it related to several agencies, including the Regional Employment Training Consortium (RETC) and Palm City Sanitation District, due to the fact that the Mayor's position had become vacant; and

WHEREAS, the substitutions in representation set forth in Resolution No. R-264734 did not comply with the enabling legislation establishing those agencies since it is required that the presiding officer of the City be a member on each; and

WHEREAS, in the absence of a Mayor, the Deputy Mayor assumes the duty of presiding officer; and

WHEREAS, to comply with the law, it is necessary to include the presiding officer as a member to the above-cited agencies;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-264734, dated December 16, 1985 be and the same is hereby amended by amending items 3 [Regional Employment Training Consortium] and 11 [Palm City Sanitation District] to read as follows:

3. REGIONAL EMPLOYMENT TRAINING CONSORTIUM

Ed Struiksma - representative; William Jones - alternate
Bill Cleator - representative; Uvaldo Martinez - alternate

11. PALM CITY SANITATION DISTRICT

Ed Struiksma - representative; Uvaldo Martinez - alternate
