

RESOLUTION NUMBER R- 265037

ADOPTED ON FEB 10 1986


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to pursue feasibility and planning studies related to the Sears' property on Cleveland Avenue for a new Central Library and to report to the City Council regarding possible methods of financing this potential acquisition.

BE IT FURTHER RESOLVED, that Councilman Bill Cleator is hereby designated the City Council's liaison to the City Manager's negotiating team.

BE IT FURTHER RESOLVED, that the Center City Development Corporation is hereby requested to continue the \$230,000 work program approved by the City Council in October 1985 to investigate the appropriateness of the construction of a new Central Library, downtown City administrative space needed through 2025, cultural facilities, and/or joint public-private facilities at the Community Concourse with regard to the Phase I studies in progress, but to suspend the expenditure of the remaining \$125,000 until after a decision has been made with regard to the new location for the main library and to report to the Public Services and Safety Committee on April 16, 1986.
