Aldo Chiappone	Utilities	\$2,500.	Mr. Chiappone is a Plant Maintenance Supervisor in the Metro Division. He designed a ferric chloride feed pump for Point Loma and Metro II. This is expected to save \$17,286.35 in equipment costs. This is a partial award pending a 12-month review.
Jack Mead	Park & Recreation	\$1,802.38	Mr. Mead is a Pool Maintenance Supervisor in the Central Division. He suggested the installation of heavy duty pipe on the pool solar blanket reels. One years experience has shown a savings of \$9,424.60 in energy and replacement costs. This is the remaining of his award.
