

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of DREW FORD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of POLICE SEDANS (PASTELS) Item 1 - fifteen (15) Police Sedans (1986 Ford LTD Crown Victoria "S" model) at a cost of \$10,486.25 each, for a total cost of \$157,293.75 and Item 2 - ten (10) Police Sedans (1986 Ford LTD Crown Victoria) at a cost of \$11,204.25 each, for a total cost of \$112,042.50, for a combined total of \$269,336.25; terms net 15 days, plus sales tax, less trade-in allowance as follows:
