1. That the street reservation in Lots 1 and 113 of Bernardo Heights Unit 20 Map 11099, as more particularly shown on Drawing No. 22363-D on file in the office of the City Clerk as Document No. RR-265065-/, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until the final subdivision map for Carmel Mountain Ranch Unit 7 (TM 84-0912) has been approved by Council action. In the event that the final map is not approved by June 10, 1988, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
