BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with COOPER AND ASSOCIATES for engineering services for the design of Sewer and Water Main Replacement Groups 460 and 461, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 265074 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,087 for Sewer Main Replacement Group 460 and \$14,708 for Sewer Main Replacement Group 461 from the Sewer Revenue Fund 41506, Annual Allocation for Sewer Main Replacements (CIP No. 44-001), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$86,323 for Water Main Replacement Group 460 and \$74,171 for Water Main Replacement Group 461 from the Water Revenue Fund 41502, Annual Allocation for Water Main Replacements (CIP No. 73-083), is hereby authorized.
