WHEREAS, the existing Conflict of Interest Code for the Fire Department was adopted by Resolution No. 218250 on April 27, 1977; and

WHEREAS, Exhibit A thereto set forth the designated positions covered by the Conflict of Interest Code at the time of its adoption; and

WHEREAS, since its adoption in 1977, changes in position titles, addition of positions and classifications make it necessary to revise Exhibit A to the Fire Department Conflict of Interest Code to account for and designate those positions which are now required to file reports under the provisions of the Political Reform Act of 1974; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Fire Department Conflict of Interest Code, adopted by Resolution No. 218250, dated April 27, 1977, be and the same is hereby amended by amending Exhibit A thereto, entitled "Designated Positions, Duties and Categories" to incorporate and designate those positions as set forth in the amended listing thereof on file in the office of the City Clerk as Document No. RR- 265078 .
