WHEREAS, the existing Conflict of Interest Code for the Property Department was adopted by Resolution No. 219093 on August 17, 1977; and


WHEREAS, Exhibit A thereto set forth the designated positions covered by the Conflict of Interest Code at the time of its adoption; and

WHEREAS, since its adoption in 1977, changes in position titles, addition of positions and classifications make it necessary to revise Exhibit A to the Property Department Conflict of Interest Code to account for and designate those positions which are now required to file reports under the provisions of the Political Reform Act of 1974; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Property Department Conflict of Interest Code, adopted by Resolution No. 219093, dated August 17, 1977, be and the same is hereby amended by amending Exhibit A thereto, entitled "Designated Positions, Duties and Categories" to incorporate and designate those positions as set forth in the amended listing thereof on file in the office of the City Clerk as Document No. RR- 265081.

EXHIBIT "A"

<u>Position</u>	<u>Duties</u>
Property Director	Directs the activities of the Property Department which encompasses negotiations for acquisition, lease, disposal and valuation of real property interests and public event facility operations. Categories 1 and 2
Assistant Property Director Deputy Director	Administers departmental policies and programs involving negotiations for acquisition, lease and disposal of real property interests and appraisal activities; acts for Property Director in his absence. Categories 1 and 2
Property Services Supervisors Supervising Property Agent	Supervises negotiations by subordinate Property Agents and negotiates with special clients in the area of acquisition, lease and disposition of real property interest; makes and reviews appraisals in connection with real property transactions. Categories 1 and 2
Associate and Assistant, and Property Agents Agricultural Lease Managers	Negotiates for acquisition, disposal and lease of real property interests; makes and reviews appraisals in connection with real property transactions. Categories 1 and 2
Facility and Assistants Facility Managers	Directs public event facility operations within the scope of established policies and practices; negotiates and administers service and event use contracts. Category 2
Community Development Specialists Project Officers	Negotiates contracts with developers, consultants, and contractors related to use or improvement of City and private property; coordinates the loan of public funds to private parties; issues bonds. Categories 1 and 2
