WHEREAS, the existing Conflict of Interest Code for the Park and Recreation Department was adopted by Resolution No. 218870 on July 20, 1977; and

WHEREAS, Exhibit A thereto set forth the designated positions covered by the Conflict of Interest Code at the time of its adoption; and

WHEREAS, since its adoption in 1977, changes in position titles, addition of positions and classifications make it necessary to revise Exhibit A to the Park and Recreation Department Conflict of Interest Code to account for and designate those positions which are now required to file reports under the provisions of the Political Reform Act of 1974; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Park and Recreation Department Conflict of Interest Code, adopted by Resolution No. 218870, dated July 20, 1977, be and the same is hereby amended by amending Exhibit A thereto, entitled "Designated Positions, Duties and Categories" to incorporate and designate those positions as set forth in the amended listing thereof on file in the office of the City Clerk as Document No. RR- 265083 .
