

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of SUPERIOR TRANS-MED is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FIVE (5) MOBILE INTENSIVE CARE UNITS (Stoner Type III) at a cost of \$53,978.15 each, for a total cost of \$269,890.75; terms net 30 days, plus sales tax, less trade-in allowance as follows:
