BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of ALLIED CORP., CHEMICAL SECTOR, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing AN-IONIC OR NON-IONIC POLYMER for the Point Loma Wastewater Treatment Plant as may be required for a period of two (2) years beginning March 1, 1986 through February 29, 1988, with a 30 day cancellation clause, at a cost of \$0.69 per pound, for a total estimated cost of \$103,500.00; terms net 30 days, plus sales tax; with an option to renew contract for up to three (3) additional one (1) year periods with a price escalation beginning the second contract year and each option year thereafter not to exceed 6% of prices in effect at the end of each prior year.
2. That a contingency contract is hereby authorized for AN-IONIC OR NON-IONIC POLYMER with DIATEC POLYMERS, the second low, cost-effective bidder, for Diatec 2541S in the event the primary contractor is unable to deliver the polymer at any time during the contract period, per prices on file in the Purchasing Department; terms net 30 days, plus sales tax.
