BE IT RESOLVED, by the Council of The City of San Diego as follows:

GVW (1986 Chevrolet C631305/ZW9) at a cost of \$10,439.59 each; Item 9 seven (7) each Cab and Chassis, 3/4 ton (1986 Chevrolet CC20903ZW9) at a cost of \$9,101.00 each; Item 11 one (1) each Cab and Chassis, one ton (4x4) (1986 Chevrolet CK 31003) at a cost of \$11,994.41; Item 13 one (1) each Pickup Crew Cab, one ton (1986 Chevrolet CC30943E63/AS3) at a cost of \$11,989.35; Item 15 one (1) each Van/Panel (4x4) (1986 Chevrolet CK10906/ZW9) at a cost of \$12,726.56; for a combined total cost of \$294,728.89; terms net 10 days, plus sales tax.
